



## INTRODUCTION

Lolu shicilelo Iwe-12 Iwe-Under the Baobab Tree LoMhlaziyi-zikhalo We-FAIS luhetha ikota yesibili ku 2016. Kulolu hlelo siye sakhetha ukugxila kulezo zikhalo ezibandakanya amapholisi okungcwaba, okuyiwona ewuhlobo lomshwalense ovame kakhulu eNingizimu Afrika futhi lapho khona ngaphansana nje kwe-90% yawo onke amakhava ezingcuphe kungawalolu hlobo lomshwalense. Amapholisi okungcwaba abaliwe lapho kuchazwa ibhizinisi losizo okusho ukuthi izinzuso ezinikwayo azinakuba ngaphezulu kwe-R30 000. Nakuba amapholisi omngcwabo eyindlela yokuqinisekisa ukuthi umndeni onomshwalense nalabo abencike kumuntu onomshwalense akudingeki bathwale umthwalo wezimali ongaphezu kwesilinganiso ukuze bakhokhele umcimbi womngcwabo, ngokuvamile iqiniso liba ngokwehluke kakhulu kulabo abasele ngemuva

futhi abathembele ezinzuzweni ezinikezwayo. Ngesizathu sokuthi ngokungafani nezinhlobo ezijwayelekile zomshwalense wokufa (life cover) lezo eziba nokwesekwa ngokwesimo sempilo yomuntu (medical underwriting) ngesikhathi sokufaka isicelo ukuze kukalwe ubungako bengcuphe (risk) obulethwa yiloyo okubhekwe ukuba abe yikhasimende, amapholisi omngcwabo awasihlolli isimo sempilo yomuntu ukuze kukalwe ubungako bengcuphe obulethwa yiloyo muntu okubhekwe ukuba abe yikhasimende. Ngenxa yalokho la mapholisi abeka imingcele njengezinkathi zokulinda nokunye okuyaye kungafakwa kupholisi ukuze kudanjiswe ingcuphe elethwa ngamakhasimende aqinisekisiwe ngokwemukelwa naphezu kwanoma yiziphi izimo ezingezinhle zezempiro. Kuphakathi kokuthi lezi zinkathi zokulinda naloko okuyaye kungafakwa kupholisi akucatshangelwa noma

kudalulwe kubafaki-zicelo (prospective clients) ngesikhathi sokufakwakwesicelo sepholisi. Amakhasimende amanangi asala edumele lapho amakileyimu esenqatshwa ngenxa yokuthi ukuphila komuntu othathe umshwalense akuhambisani nezimfuneko zephоли bese kudliwa yileyo mishwana ebeka ezinye izimo eceleni (exclusionary clauses). Nokho, amakhasimende anaso isivikelo ngokuthi uMthetho We-FAIS kanye nokuhambisana nawo uHlaka Lokuziphatha Oluvamile Lwabahlinzeki Bamasevisi Ezimali Abagunyaziwe Nabameleli (General Code of Conduct for Authorised Financial Services Providers and Representatives [uHlaka]) kubizela ukuthi umhlinzeki wamasevisi ezimali aqale ngokuthola lonke ulwazi (information) oluphathele nendaba nolutholakalayo ukuze kuqinisekiswe ukuthi lo mkhiqizo otuswayo awufaneleki nje kuphela kodwa futhi nokudalulwa okufunekalyo kuzokwazi ukwenziwa ukuqinisekisa ukuthi ihasimende libekwa esimeni sokwenza isinqumo esisekelwe olwazini.



## UKUHLAZIYWA KODABA 1

Umgomo oyinhloko womshwalense wukunxephelwa umnipholisi ngokulahlekelwa, okuvame ukuba ngokwezimali, okwenzeka ngenxa yenhekelele ethathelwe umshwalense. Ukuvumela ukuba umnipholisi anxeshezelwe ngokulahlekelwa okungamthinti loyo muntu ngokwezimali kungadalinkinga engokwesimilo, njengoba kobe kungekho sizathu noma isisusa sokuba loyo muntu avimbele lokho kulahlekelwa. Ngenxa yalokho isizathu isifiso sokuthathwa komshwalense siyimfuneko eyisisekelo sokunikwa kweholisi yomshwalense, okukwenza kube ngokomthetho futhi kufaneleke. Umuntu uba nesifiso sokuthathwa umshwalense ngento ethile okungathi ukulahleka noma ukulimala kwayo kubangele ukuba loyo muntu alahlekelwe ngokwezimali noma ngezinye izindlela. Ngokomshwalense wokungcwaba isimiso sesifiso sokuthathwa komshwalense sivame ukubhekwa njengesifanelekile uma abathintekayo behlobene eduze futhi loyo oyothola izinzu zo mshwalense eyolahlekelwa ngokwezimali ngokufa kwaloylo othathelwe umshwalense, njengabantu abashadile abanokuthathelana umshwalense ngokuphila kwabo. Isifiso sokuthathwa komshwalense kume sibe khona lapho kufakwa isicelo somshwalense wokufa futhi akudingeki sivele ngoba sekufakwa ikileyimu.

## UDABA LUKA-“NKS M”

### Facts

Umfakisikhalo wayefake isicelo sepholisi yomngcwabo saphumelela futhi wayefake umyenri wakhe njengomuntu othathelwe umshwalense ngokuphila kwakhe kuleyo pholisi. Kubalulekile ukuqaphela ukuthi umfakisikhalo nomyeni wakhe babeshade ngokoMthetho Wesiko. Emva kokuba iqalile ukusebenza le pholisi, umyenri womfakisikhalo washona emva kokuba le pholisi isakhokhelwe amaprimiyamu (premiums) amabili kuphela. Emva kokufaka ikileyimu ukube athole isamba okufanele sikhohwe yilo mshwalense esiu-R10 000.00 umfaki-sikhalo washaqeka ukuthola ukuthi ikileyimu yakkahlelwa ngesisekelo sokuthi ngokuyangommangalelw (respondent) umfakisikhalo wayengenasithakazelo esinokuthathelwa umshwalense. Ngapezu kwalokho ummangalelewa wayethe futhi umfakisikhalo akazange ahlangabezane nenkathi yokullinda yeprimiyamu okungenani eyodwa.



## UKUNGENELA KWETHU

Lapho leli Hhovisi lithola lesi sikhalo lasibhekisa kummangalelw ngokwemithetho elawula ukusebenza kwaleli Hhovisi. Ummangalelw wacelwa ukuba anike leli Hhovisi amaphepha abonisa ukuthi kwahlangabezanwa nalokho okufunwa wuHlaka Lokuziphatha Oluvamile Lwabahlinzeki Bamasevisi Ezimali Abagunyaziwe Nabameleli (uHlaka) futhi ngokuthe ngqo abonisa ukuthi ummangelelw waluthola yini lonke ulwazi oluphathelene nendaba nolutholakalayo ukuqinisekisa ukuthi lo mkhiqizo otuswayo wawuzifanelekela kahle yini izidingo nezimo zomfakisikhalo.

Kuloku, kwafunwa futhi ukuba ummangalelw akhanyise izisekelo zokukhahlela ikileyimu njengoba babukhona ubufakazi bokuthi umufi wayemkhophilie ilobolo umfakisikhalo. NgokoMthetho Wokuqaphela Imishado Engokwesiko (Recognition of Customary Marriages Act), umshado ongokwesiko ubhekwa njengosebenzayo uma izingxoxo zokubonisana (negotiations), imicikilisho (rituals) nemicimbi kuhambisana nomthetho wesiko. Ukuthi lowo mshado awubhalisiwe eMnyangweni Wezasekhaya akuwenzi nangayiphi indlela ukuthi lowo mshado ube ngongenakuqashelwa.

Kwatholwa impendulo evela kummangalelw ayeyeza kuyo ukuthi wayeye wasibukeza isinqumo esasithathwe ekuqaleni nokuthi wayesekwemukele ukuthi ngempela umfakisicelo wayenaso isithakazelo sokuthathelwa umshwalense ngenxa yokuthi lo mshado wawuhlangabezanile nezinxoxo, imicikilisho nemicimbi ngokoMthetho Wesiko.



## IZIFUNDO EZIFUNDIWE:

1. Isithakazelo sokuthathelwa umshwalense siyimfuneko eyinhloko kunkontraki yomshwalense esebezayo, futhi kudingeka kuqondakale ukuthi noma ubani ofaka isicelo somshwalense ngokuphila;
2. Abashadikazi bayisibonelo sokuhlobana okuletha isithakazelo sokuthathelwa umshwalense futhi kuhlanganisa nalabo abashade ngokomthetho wesiko;
3. Isithakazelo sokuthathelwa umshwalense kudingeka sibe khona ngesikhathi sokufakwa kwesicelo somshwalense, futhi asidingeiki lapho sekufakwa ikileyimu.

## Ukuhlaziywa kodaba 2

Isimo ebевые sikhona yilesimo sempilo ngokwezokwelapha esingafakiwe ekukhokhelweni yinkampani yomshwalense ngoba lesimo kwakukholelw ukuthi sasikhona ngaphambi kokuba loyo muntu athole ipholisi kuleyo nkampani ethile yomshwalense. Lokhu kuchazwa okubanzi kusetshenziwa yizinkampani zomshwalense, zona ezihlinzeka imikhiqizo efana namapholisi omngcwabo, ukuze zenqabele amakileyimu lapho umufi eshone ngokuqondile noma ngokungaqondile ngenxa yesimo sempilo ngokwezokwelashwa ebесikhona ngaphambi kokuba ipholisi iqale ukusebenza. Izinkampani zomshwalense zinalo ilungelo lokuwenqaba la makileyimu ngoba, ngokungafani nezinhlobo ezivamile zomshwalense wokufa, ikhava yamapholisi omngcwabo inikwa ngaphandle kokuba leyo nkampani yomshwalense yenze ukuhlolwa kwempilo ngokwezokwelapha kuqala, futhi ngaphandle kokuya ingcuphe elethwa yilokho kuphila komuntu okuzokhokhelwa wumshwalense. Ngakho-ke kubaluleke kakhulu ukuba umhlinzeki wamasevisi ezimali athole lonke ulwazi (information) oluphathelene nendaba nolutholakalayo kuloyo muntu osethubeni lokuba yikhasimende okuzovumela ukuba kudalulwe ngemininingwane egcwele ukungafakwa kwalessimo nanomasiphi esinye isiwombe lapho umshwalense ongeke ukhokhe khona. Ukudalulwa kwalolu lwazi kuzovumela ikilayenti (client) ukuba lenze isinqumo esisekelwe olwazini sokuthi le pholisi etuswayo iyafaneleka yini kulo ngokwezidingo nezimo zalo.

## ISEHLAKALO SIKA-‘MNU. L’

### Facts

Umfakisikhalo wayenepholisi yomngcwabo eghubekayo nommangalelw eyayiqalise ngoMeyi 2015, futhi wayekhokha iprimiyamu yenya eyi-R269.00. Le pholisi yayiye yalungiselelw ukukhokhela ubaba ngomshado (stepfather) womfakisikhalo kanye namanye amalungu omndeni. Phakathi noMashi 2016 umfakisikhalo wayeye wafaka ikileyimu kummangali emva kokushona kukababa wakhe ngomshado, futhi ikileyimu laliye lakhahlelw ngesisekelo sokuthi umufi wayephathwe yisimo esasivele sikhona.



Umfakisikhalo wema kwelokuthi lokhu kwakungazange kudalulwe kuye lapho ipholisi iqalisana nanokuthi wayetshelwe okokuqala ngalokhu kubekwa eceleni lapho efaka ikileyimu yakhe. Ngaphezu kwalokho umfakisikhalo wayenombono wokuthi njengoba ayengazange ake eqiwe yiprimiyamu ummangali kufanele ayemukele ikileyimu yakhe, khona-ke wabe eseza kuleli Hhovisi ukuze athole usizo.

### UKUNGENELA KWETHU

Isikhalo sathunyelwa kummangalelwaa owabe esecelwa ukuba anike amaphepha adingekayo ngokoMthetho i-FAIS kanye nokuhambisana nawo uHlaka Lokuziphatha Oluvamile Lwabahlinzeki Bamasevisi Ezimali Abagunyaziwe Nabameleli. La maphepha, okwakufanele ahlanganise nerekhodi leseluleko esanikwa ikilayenti, kwakufuneka abonise ukuthi ummangalelwaa akazange agcine ngokuthola lonke ulwazi okupathelene nendaba nolutholakalayo kumfakisikhalo ukuze abone ukuthi lo mkhiqizo wawufanelekile yini ngokwezidingo zekilayenti, kodwa futhi nokuthi zonke izici eziwumongo wepholisizaziye zadululwa. Ukudalulwa kvezici eziwumongo wepholi kwakuyoqinisekisa ukuthi umfakisicelo wayeye wabekwa esimeni sokuba enze isinqumo esisekelwe olwazini.

Ngakho-ke ummangalelwaa waziswa kwakufuneka athole ulwazi olunjengomlando wokwelashwa womfakisikhalo kanye nalabo ayefisa ukubathathela umshwalense kule pholisi. Lolu lwazi lwaluyokwenza ummangali akwazi ukuxoxa ngendaba yokuthi umuntu onjengomufi angase angakwazi ukufaka ikileyimu ephumelelalo uma kwenzenka efa ngokwendlela yemvelo. Ummangali wakuvuma ukushiyeka kwakhe kule ndaba wabe eselikhokha inani lekileyimu eliyi-R10 000 elisikhokhela ngokugcwele nangokokugcina isikhalo.

### IZIFUNDO EZIFUNDIWE

4. Emikhiqizweni yomshwalense efana namapholisi omngcwabo, lapho kungenziwa khona siqinisekiso ngesikhathi sokufakwa kwesicelo, kuyaye kufakwe kupholisi imishwana ebeka izinto ezithile eceleni ezibonisa lokho umshwalense ongezukukukhkhela maqondana nanoma yisiphi isimo esingokwempilongokwezokwelapha esivele sikhona ukuze kunqandwe ingcuphe elethelwa inkampani yomshwalense.
5. Lapho ufuna ukuthenga ipholisi yomngcwabo qiniseka ngaso sonke isikhathi ukuthi umhlinzeki wamasevisi ezimali wakho udalula lonke ulwazi oluwumongo ikakhulukazi ngokupathelene nalezo zinto ezingeke zikhokhelwe mayelana nezimo ebezivele zikhona kanye nanoma ziphi ezinye iziwombe ezingeke zikhokhelwe. Lokhu kuzovumela umuntu ukuba anqume noma lo mkhiqizo otuswayo uyamfanelekela yini ngokwezidingo nezimo zakhe.

### Ukuhlaziya kodaba 3:

**Ngokupathelene namapholisi omngcwabo, izingane ezondliwayo zivame ukukhokhelwa zize zifinylele ubudala beminyaka engama-21, noma-ke uma umminipholisi ekwazi ukuveza ubufakazi bokuthi leyo ngane iyisitshudeni noma ngokwezimali incike kumzali. Ngaphezu kwalokhu, izingane ezikhubazekile ngokomzimba noma ngokwengqondo ngokuvamile ziyawkazi ukunakekelwa ngokwepholisi inkathi engabekelwe mngcele. Iningi lezikhalo kulo mkhakha livela ngezingane ezazingaphansi kobudala beminyaka engama-21 ngesikhathi ipholisi iqala, futhi kusobala ukuthi abahlinzeki bamasevisi ezimali bayehluleka ukwazisa amakilayenti abo ngaloku kubekelwa eceleni lapho befaka ingane eyondliwayo kumshwalense wepholisi yomngcwabo.**

### UDABA LUKA-“MNU. S”

#### Facts

Umfakisikhalo, owayewumnini wepholisi yomngcwabo eyayituswe wummangalelwaa, wathi ummangalelwaa akamazisanga ukuthi kukhona umngcele wobudala beminyaka engama-21 ngabantu abathathelwe umshwalense njengabondliwayo ngokwepholisi yakhe yomngcwabo.

Umfakisikhalo wayekhokha iprimiyamu maqondana naye nomfowabo omncane, owayebhaliswe kule pholisi njengomondliwa. Lapho iqala ukusebenza ipholisi umfowabo womfakisikhalo wayeneminyaka eyi-18 ubudala kwathi lapho eshona wabe eseneminyaka engama-24. Ikiliyemu eyafakwa wumfakisikhalo kamuva yakhahlelwa ngesisekelo sokuthi umshwalense womufi waphelelwa yisikhathi lapho efinyelela ubudala beminyaka engama-21. Umfakisikhalo wama kwelokuthi lokhu kwakungazange nanini kuchazwe kuye ngesikhathi kuthengiselanwa noma ngezincwadi zokuvuselela zanjalo ngonyaka; wabe eseza kuleli Hhovisi ukuze ummangalelwaa akhokhe inzuzu egeweleye eyi-R10 000.

### Ukungenela Kwethu

Lapho kufika kithi lesi sikhalo, ummangalelwaa wacelwa ukuba anike leli Hhovisi irekhodi leseluleko esanikwa ikakhulukazi ngokudalulwa okwéniwa maqondana nalezo zinto ezingeke zikhokhelwe ngabantu abondliwayo abathathelwe umshwalense ngokwale pholisi. Ummangalelwaa akakwazanga ukwenza kanjalo, kodwa esikhundleni salokho wamane wabhekisa kumaphepha epholisi ayequkethe lo mshwana, ngaso sonke isikhathi ephikelela ngokuthi lo mngcele wawusebenza kuyo yonke imboni futhi kwakufanele ukuthi ikilayenti lazi ngawo. Nokho ummangalelwaa wayezimisele ukukhipha isamba somusa esiyi-R5000 ngokwehluleka kwakhe ukugcina la maphepha aphantelene nendaba. Umfakisikhalo waqala ngokuyenqaba le offer, ephikelela ngokuthi makuhlaikhokhelwe inzuzzo epehelele, nokho wagcina eyemukele i-offer njengokukhkhela okugcwele nokugcina ngalesi sikhalo.

### IZIFUNDO EZIFUNDIWE:

6. Kubalulekile ukuthi wazi nganoma yimphi imingcele ebekwe kupholisi yakho yomngcwabo ikakhulukazi ngokupathelene nabomndeni osabalele (extended family) abathathelwe umshwalense.
7. Ngaphandle kokuba umuntu ekwazi ukuveza ubufakazi besithakazelo sokuthathelwa umshwalense,



umshwälense angeke ubakhokhele abondliwa abangaphezu kweminyaka engama-21 ubudala.

8. Nakuba lokhu kungase cube yinto esebezena kuyo yonke imboni, umhlinzeki wamasevisi ezimali ulokhu enawo umthwalo wokudalula leyo mingcele yomshwälense ukuze anike ikilayenti ithuba lokwenza isinqumo esisekelwe olwazini.

#### Ukuhlaziya kodaba 4:

Izinkathi zokulinda azinakugwemeka kumshwälense womngcwabo ngenxa yokuthi ekuqaleni akukho ukuqinisekiswa kwempilo ngokwezokwelapha okwenziwayo ukuhlola ingcuphe elethwa yikilayenti. Njengoba kushiwo esingenisweni ngenhla, khonake amapholisi omngcwabo abeka imingcele njengezinkathi zokulinda, eziqala ngosuku umuntu othathe umshwälense aba nelungelo ngalo ngalovo mshwälense, ngokujwayelekile okuba lapho kutholwa iprimiyamu yokuqala, futhi kule nkathi akukho nzuzo ekhokhwayo uma ukufa kwenzeza ngezimbangela ezingokwemvelo. Izinkathi zokulinda zivame ukuchazwa njengenkathi lapho kungekho khona ukufaka amakileyimu phakathi nezinyanga zokuqala ezi-3, ezi-6 noma ezi-9 ipholisi iqalile. Kubalulekile ukuba umuntu akuqaphele ukuthi inkathi yokulinda iya ngobude bethemu (term), hhayi inani lamaprimiyamu akhokhiwe. Ngamanye amazwi, amaprimiyamu ayi-6, ngokwesibonelo, awaqinisekisi ukuthi ikileyimu izophumelela uma umufi eshone ngenyanga yesi-5 yenkathi yokulinda eyizinyanga eziyi-6.

#### UDABA LUKA- 'MNU. F'

##### Facts

Umfakisikhalo wayefake isicelo somshwälense womngcwabo kummangalelw saphumelela, lapho kufakte nogogo wakhe njengomuntu wokukhokhelwa uma efa. Ipholisi yaqala ukusebenza ngomhla ka-1 Okthoba 2012 futhi umfakisikhalo kwakudingeka akhokhe ungakadluli umhla ka-15 wenyanga ngayinye. Iprimiyamu yomfakisikhalo yokuqala yakhokhwa ngomhla ka-10 Okthoba 2012 emahhovisi ommangalelw, kwahlelw ukuthi konke ukukhokha okulandelayo kwakuzokwensiwa ngendlela efanayo.

Ngenxa yalokho umfakisikhalo akazange anikwe ezinye izindlela zokukhokha.

Kamuva umfakisikhalo wathola umsebenzi kwesinye isifundazwe futhi wacela ilungu lomndeni ukuba limkhokhele. Isivumelwanosabuwukuthi umfakisikhalo uzofaka iprimiyamu ku-akhawunti yaleli lungu lomndeni bese lona liyikhokha kummangalelw egameni lomfakisikhalo. Phakathi noDisemba 2015 ugogo womfakisikhalo washona kungakadingeki ukukhokhwa kweprimiyamu. Lapho umfakisikhalo efaka ikileyimu watshelwa ukuthi ikileyimu ikhahleliwe ngenxa yokungakhokhwa kwamaprimiyamu. Ummangalelw wathi umfakisikhalo wayengazange akhokhe amaprimiyamu amathathu ngenxa yalokho ipholisi yomfakisikhalo yayisenkathini yokulinda ukusuka kuJuni 2015. Ngakhoke ummangalelw wathi ikileyimu yomfakisikhalo yayifakte phakathi nenkathi yokulinda yezinyanga ezintathu futhi ngaleyoo ndlela yayingeke yemukeleke. Umfakisikhalo yena wathi wayengazange aziswe ukuthi ipholisi yakhe yayisenkathini yokulinda ngenxa yokungakhokhwa kwamaprimiyamu lapho ekhokha iprimiyamu phakathi noJuni 2015 futhi wayenombono wokuthi ipholisi yakhe yayiloku isebeza ngaphandle kwemibandela yokukhokhwa komshwälense uma nje eqhubeka nesibopho sakhe sokukhokha amaprimiyamu.

##### UKUNGENELA KWETHU:

Lapho sithola lesi sikhalo sacela ummangalelw ukuba asinike ubufakazi bokuthi umfakisikhalo wayazisiwe ngezimo lapho izinzuso zazingeke zikhokhwe khona. Ngokukhethekile, sacela ummangalelw ukuba aveze ubufakazi bokuthi umfakisicelo wayazisiwe ukuthi uma kwenzeza engakhokhwa amaprimiyamu ipholisi iyongamuka kodwa uma kamua ewakhokha amaprimiyamu asilele ipholisi iyovuselelw bese iba senkathini yokulinda entsha yezinyanga ezintathu. Ummangalelw akawazanga ukusinika noma yibuphi ubufakazi obubhaliwe ubudingekayo kodwa kunalokho wasinika ikhophi yamaphepha epholisi wona ayemane

esho ukuthi ipholisi izokhanselwa emva kwezinyanga ezintathu ezilandelanayo zokungakhokhwa kwamaprimiyamu kodwa ayengasho lutho ngemibandela emayelana nokuvuselelw kwepholi. Ummangalelw wagcina ngokulivuma iqiniso lokuthi lapho kwemukelwa lawo maprimiyamu ákhokhwa ngoJuni ummeleli wakhe wehluleka ukwazisa umfakisikhalo ukuthi lokho kukhokha kwakuwukuvuselela ipholisi esinqamukile nangemiphumela lokho okwakuza nayo. Ummangalelw wavuma futhi ukuthi umfakisikhalo wanika umbono wokuthi ipholisi yayiloku iqbubea futhi nezinzuze eziphelele zilokhu zikhona. Ngenxa yalokho, ummangalelw wavuma ukukhokhela umfakisikhalo inzuzu egeweleyi-R20 000.00

##### IZIFUNDO EZIFUNDIWE:

9. Inkotrazi yomshwälense idala umthwalo kuzo zombili izinhlangothi ezenza isivumelwano. Ngakhoke nakuba umnikimshwälense eyamukela ingcuphe elethwa yikilayenti, umnikimshwälense ukwenza lokhu ngokushintshiselana ngamaprimiyamu akhokhwa yikilayenti.

10. Uma kwenzeza engakhokhwa amaprimiyamu umnikimshwälense unelungelo lokuyikhansela inkotrazi yomshwälense. Ngakhoke umuntu othathe umshwälense kumele aqiniseke ukuthi onke amaprimiyamu akhokhwa ngesikhathi ukaze agweme ukukhanselwa kwepholi.

#### Ukuhlaziya kodaba 5:

**Umqinisekisi (underwriter) yinkampani yomshwälense yenkathi ende ebhaliswe ku-Financial Services Board (iBhodi Lamasevisi Ezimali) okuyiyona eyamukela amaprimiyamu akho futhi enomthwalo wokukhokha izinzuso uma kuba khona ukufa. Ngakho-ke, isici esibaluleke kakhulu wukuthi ipholisi kufanele iqinisekiswe yinkampani yomshwälense yenkathi ende. Lokhu kwenzelwa ukupinisekisa ukuthi nakanjani ilungu lizokhokhelwa ngekileyimu esemthethweni uma kwenzeza efa umuntu othathele umshwälense ngale pholisi. Ngaphezu kwalokho, umnininipholisi kumele**

**aqinisekise ukuthi uthola ikhophi yamaphepha epholisi, okufuneka ibe nalo igama lenkampani yomshwälense eqinisekisa leyo pholisi. Futhi loyo ongase abe yikilayenti kumele aqapha ukuthi le pholisi yomngcwabo elifuna ukuyithenga iqinisekiswe wumhlinzeki wamasevisi ezimali orejistiwe. Uma kwenzeka umuntu engaqiniseki ngokuba semthethweni kwenkampani ethile, iBhodi Lamasevisi Ezimali linika imininingwane yazo zonke izinkampani eziku-website yalo.**

## **UDABA LUKA-'NKS M'**

### **Facts**

Ngo-2009 umfakisikhalo wafaka isicelo sepholisi yomngcwabo kusosayathi yokungcwaba (umasingcwabane, burial society) owayesebenzela endaweni ahlala kuyo. Phakathi nalesi sikhathi, le sosayathi yokungcwaba ngokwayo yayifake isicelo sepulani lokusekela amasosayathi okungcwaba enkampanini ethile eyabe isiba wumqinisekisi wale sosayathi yokungcwaba. Leli pulani lokusekela amasosayathi okungcwaba lalihloselwe ukukhava amalungu ale sosayathi yokungcwaba ngazo zonke izindleko zokungcwaba kumuntu oyilungu eliyinhloko kanye nabondliwa abangabantu abadala abane. Ikhava yepulani lokusekela amasosayathi okungcwaba laqala ukusebenza ngoMeyi 2010.

Umfakisikhalo wayewakhokhe ngenkuthalo amaprimiyamu omshwälense wakhe womngcwabo ukusuka ekuqaleni kwaze kwaba sekushoneni komunye wabathathelwe umshwälense ngokwale pholisi. Umfakisikhalo wabe esefaka ikileyimu njengokufanelekile, yona kamuva eyabe isikhahlelwa ngesisekelo sokuthi umfakisikhalo wayeye walungisa (update) ipholisi yakhe futhi, ngenxa yalokho, kwase kudaleke inkathi yokulinda entsha. Umfakisikhalo wasisola isinqumo sesosayathi yokungcwaba sokukhahlela ikileyimu yakhe kumqinisekisi futhi watshelwa yisosayathi yokungcwaba ukuthi ipholisi yayo nomqinisekisi yayinqamukile ngoba amanye amalungu ale sosayathi yokungcwaba ayengazange akhokhe amaprimiyamu awo. Emva kwalokho umfakisikhalo waqondisa isikhalo sakhe kumqinisekisi wabe esetshelwa ukuthi ipholisi yasekuqaleni

yesosayathi yokungcwaba yayinqamuke ngoSeptemba 2012 ngenxa yokungakhokhwa kwamaprimiyamu. Umqinisekisi washo nokuthi le sosayathi yokungcwaba eqinisweni yayishintshe igama layo phakathi no-2012 yafaka isicelo senye ipholisi yokungcwaba ngaphansi kwegama layo elisha. Naleylo pholisi yanqamuka ngenxa yokungakhokhwa kwamaprimiyamu.

Umfakisikhalo waba sesimeni sokuthi kokubili umqinisekisi kanye nesosayathi yokungcwaba babekwenqaba ukuba nesibopho ngale kileyimu. Umfakisikhalo wathi wayengazange aziswe ngokushintha kwegama nanokuthi wayengaziswanga ngokunqamuka kwepholis yesosayathi yokungcwaba. Empeleni wayelokhu ewakhokhela ize amaprimiyamu kule sosayathi yokungcwaba. Ngakho-ke, umfakisikhalo wacela usizo lwethu lokuba phakathi kwale sosayathi yokungcwaba nomqinisekisi kube khona onesibopho sokukhokhela ikileyimu yakhe.

### **UKUNGENELA KWETHU:**

Lapho sithola lesi sikhalo, sasibhekisa kusihlalo wesosayathi yokungcwaba yena owathi:

- Le sosayathi yayine-akhawunti yasebhange eyodwa lapho onke amalungu kwakufuneka akhokhe khona amaprimiyamu awo. Kamuva kuleyo akhawunti umqinisekisi wayeyobe esedonsa iprimiyamu yesosayathi yenya;
- Amalungu esosayathi atshelwa ukuthi akhokhe amaprimiyamu awo ngaphambi komhla ka-1 enyanganenayinyo ukuze umqinisekisi akwazi ukuthola iprimiyamu egcwele;
- Lawo mapholisi ayeye anqamuka ngenxa yokuthi amanye kumalungu esosayathi ayeye angayikhokha iprimiyamu yawo yenya noma ayekhokhe emva kwsikhathi, okusho ukuthi lapho umqinisekisi ezama ukudonsa iprimiyamu yesosayathi yenya yayingekho imali eyanele ku-akhawunti;
- Usihlalo wathi lolu wuhlelo amalungu ayevumelan ngalo emihlanganweni yawo.

Emva kwalokho isikhalo sabe kumqinisekisi

njengomhlinzeki wamasevisi ezimali ogunyaziwe. Kwadingeka umqinisekisi anike leli Hhovisi ubufakazi bokuthi umfakisikhalo wayazisiwe ngokukhanselwa kwaleli pulani lokusekela amasosayathi okungcwaba ngenxa yokungakhokhwa kwamaprimiyamu. Umqinisekisi waphikelela ngokuthi wayethumele i-SMS kusihlalo wesosayathi yokungcwaba nanokuthi kwakuwumsebenzi kasihlalo ukwazisa ngalinye ilungu lesosayathi ngokunqamuka kwale pholisi. Sazisa umqinisekisi ukuthi leyo ndlela yokwenza yayingahambisan nomoya woHlaka Lokuziphatha (Code of Conduct) nanokuthi kwakuyimfuneko ngokweMithetho Yokuvikelwa Kwabaninimapholisi (Policy Holder Protection Rules) yena azise ngalinye ilungu lesosayathi ngokunqamuka kwepholis. Umqinisekisi akakwazanga ukunika leli Hhovisi ngobufakazi obufunekayo kodwa esikhundleni salokho wabe eseveza isifiso sokukhokhela umfakisikhalo inani eligcwele lenzozo eliyi-R5000.00, okuwukukhokhelwa okugcwele nokokugcina kwalesi sikhalo.
